### RE: REVIEW OF THE ANTI-DISCRIMINATION ACT 1991

Further to the Human Rights Commission's (HRC) request for submissions to assist in the review of the *Anti-Discrimination Act 1991* The People's Revolution (TPR) has coordinated feedback from our community regarding the types of discrimination they have experienced.

The attached written submissions and video recording of TPR's public consultation session form the totality of TPR's submission and highlight that the anti-discrimination laws are **not** "protecting and promoting equality to the greatest extent possible", which was the query that the HRC were tasked with investigating.

In fact, TPR's submission highlights a concerning level of discrimination experienced by our community who have been discriminated against based on their decision / inability to either wear a face mask and/or receive an experimental medical treatment (commonly referred to as COVID-19 vaccination). Our community has shared a broad range of stories of discrimination resulting in:

- inability to access medical care and/or lifesaving treatment,
- denial of access to services,
- social isolation,
- job loss,
- inability to complete studies; and
- widespread depression and despair.

Governments appear to be justifying this discrimination on the grounds of false hopes and beliefs that vaccination and mask wearing (Control Measures) provide a high level of protection against catching and spreading SARS-COV-2 (Virus). This belief is not supported by either clinical trial data nor two years of observational evidence which clearly demonstrate that neither masks nor vaccines prevent people from catching or spreading the Virus.

Mandating these Control Measures has caused much division and segregation in the community, turning everyday Australians into criminals for simply ordering or serving a cup of coffee. Indeed, this situation is so preposterous that only the reflection of future generations will show the true perspective of how morally lost our society has become.

In this submission, we have attempted to humanise the costs of this senseless attack on good, hardworking, law-abiding Australians based on their medical decisions.

# **DISCRIMINATION BASED ON MEDICAL DECISIONS**

Our consultations unearthed hundreds of cases of discrimination (bearing in mind that for every case we received, there are thousands of stories to which we are not privy). The primary cause of the discrimination and suffering experienced by TPR's community is as a result of the mandates for face masks and vaccines.

Ironically, these mandates have been justified on the basis of public health with no consideration of:

- adverse reactions to the Control Measures,
- meaningful options for exemptions; or
- any consideration for the personal health conditions of individuals.

#### Masks

TPR's submission shows members of the public with legitimate medical exemptions for the masks due to conditions like emphysema, claustrophobia, anxiety or other breathing or psychological problems, being arbitrarily discriminated against through refusal of access to basic services and medical care, or being treated like lepers for not wearing a mask. In most of these cases, explaining that one bears a medical exemption is disregarded without cause and/or dismissed outright.

#### Vaccines

People with blood-clotting conditions, auto immune disorders, heart conditions, a history of adverse reactions to other vaccines or to the Covid-19 vaccine itself, are being denied exemptions against all logic, as their reasons are summarily deemed to be insufficient.

People with genuine concerns regarding the lack of long-term safety and efficacy data are being ignored and dehumanised as "crazy anti-vaxxers" making way for widespread and unprecedented discrimination through the loss of their ability to participate in society or retain employment.

This has fostered mass distrust of and disenchantment with all public institutions, particularly in government officials, law enforcement and medical professionals. The loss of confidence in these institutions, and the lack of support and remedy through the legal system, has led many community members to despair and belief that the government and the legal system, have been corrupted to the extent that no real solution and justice can be found through them.

History serves a warning for nations who have dared to alienate and discriminate their people, causing loss trust in their governments and legal systems:

*If the people have no faith in the law, then the law may as well not be.* 

# THE SOCIAL & EMOTIONAL COST OF MEDICAL DISCRIMINATION

In addition to themes of absolute distrust and loss of faith in public institutions and authorities, the community is expressing concerning levels of rising depression and suicidal thoughts, increased anxiety, isolation, fear, confusion, loss of hope, and many such emotions. Little wonder, given that financially vulnerable members of our communities are losing long term employment and being plunged into financial ruin with no support, consideration, or legal recourse for exercising their right to bodily autonomy; a right supposedly guaranteed to every individual in a liberal democracy.

Employers are unlawfully breaching employment contracts because of vaccination status and summarily dismissing employees without any compensation or due process and using the mandates to pass the buck and avoid responsibility.

Families, friendships, and meaningful connections are being torn asunder; students prevented from completing their studies; the sick and elderly mistreated and refused medical care; large swaths of our communities (from all walks of life and across all ages) are being senselessly ostracised from

public life, demonised, and exposed to hysterical attacks and abuses by members of the public who erroneously believe them to be threats to public health despite the fact that the masked and vaccinated also catch and spread the Virus.

The media and authorities are entirely responsible for this senseless suffering. Innocent, law-abiding members of our communities are living in fear of discrimination and retaliation if they deign to file complaints. Most have given up on seeking remedy for they have found, through harrowing experiences, that all public institutions, even those meant to protect them like Fair Work for instance, are in lockstep with other institutions to uphold the narrative despite the evident devastating cost to the community financially, psychologically, emotionally, and most disturbing of all, in regards to health.

As a member of the public stated: "it is like being in a nightmare and you can't wake up." Reason, by all accounts, appears to have given way to utter madness.

## RECOMMENDATIONS

As an organisation that loves and supports our community and our great nation and does not wish to see it fall, TPR stands in solidarity with our fellow everyday Australians who have become the disregarded victims of a political and social system that seem to have lost all sense of morality and justice.

The HRC has an opportunity to protect the Queensland community from this type of discrimination ever being able to occur again in our society by incorporating the below recommendations into the *Anti-Discrimination Act* as part of the current review:

- 1. Amend the law to unquestionably protect all members of the public against discrimination on the basis of their medical status, including but not limited to vaccination status, and ability to wear a face mask.
- 2. All and any medical procedures, without exception, must be entirely voluntary, particularly where there is a risk of injury and or death; that the exercise of that choice results in no penalty or discrimination whatsoever; and that this principle not be overridden under any circumstances; and
- 3. Individuals face no discrimination for not sharing private medical information.
